1. The Government of Tamil Nadu through Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of Chennai Kanyakumari Industrial Corridor Project. Part of this financing will be used for payments under the Contracts named above. Bidding is open to eligible Bidders from eligible source countries of ADB. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Financial Bid.
2. The Chennai Kanyakumari Industrial Corridor Project, Highways and Minor Ports Department ("the Employer") for and on behalf of the Governor of State of Tamil Nadu invites sealed bids from eligible Bidders for the construction, maintenance and completion of "Upgrading Thuraiyur-Perambalur Road (SH 142) from km 2/0 - 13/120, Km 14/640 - 27/800 and Km 29/820 - 32/0 to two lane with paved shoulders and construction of two bypasses to Nakkasalem and Kurumbalur to a length of 3.54 km from km 13/120 - 14/640 & Km 27/800 - 29/820 and maintenance of entire project stretch 30.057 km for 7 Years (in the State of Tamil Nadu on Engineering, Procurement and Construction (EPC) Mode)". ("the Works").
3. Open competitive bidding will be conducted in accordance with ADB's "Single-Stage: Two-Envelope" procedure and is open to all Bidders from eligible countries as described in the Bidding Document. . The Bidder shall have
  - the nationality of an eligible country approved by ADB
  - Minimum average annual construction turnover of INR 156,00,00,000 calculated as total certified payments received for contracts in progress or completed within last 5 years.
  - Participation in at least one contract with a value of at INR 110 Crore only (INR One Hundred and Ten Crore Only) or two contracts with a value of at least INR 82 Crore only (INR Eighty Two Crore only) in each contract within last 5 years.
