1. The Government of India has applied for financing from the Asian Infrastructure Investment Bank (AIIB) towards the cost of Chennai Peripheral Ring Road Section II & Section III (the “Project”) and intends to apply part of the proceeds for consulting services. This project is jointly co-financed by OPEC Financing for International Development (OFID).
2. The consulting services (“the Services”) include Environmental and Social External Monitoring for Chennai Peripheral Ring Road Section II & III. The consultants/ NGO’s shall also provide necessary support to Project Implementation Unit (the “PIU”) established under Tamil Nadu Road Infrastructure Development Corporation (TNRIDC). 3. The Executive Director, TNRIDC, for and on behalf of the Governor of State of Tamil Nadu, now invites eligible consulting firms (“Consultants”)/NGO’s to indicate their interest in providing the Services. Interested consultants shall provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are:
  - a. Experience in implementing similar Environmental and Social External Monitoring works under the world Bank, ADB, JICA loan assisted projects.
  - b. Experience in monitoring the implementation Resettlement Plan (RP) & Environmental Management Plan (EMP) will be given additional preference and
  - c. Consultant/ NGO’s should have implemented at least 3 similar projects.
4. The Expression of Interest (EoI) must include the following:
  - a. An introductory letter on company letterhead (with complete contact details – name of contact person and corporate role, mailing address, telephone, e-mail etc.) explaining how the firm will deliver the task;
  - b. Organizational profile;
  - c. A report for the past three years;
  - d. Short note describing implementation of similar projects pertaining to the short-listing criteria
  - e. Overview of relevant projects implemented by the consultant/ NGO’s

pertaining to the Services and the short-listing criteria outlined above and  
f. Audited Annual financial reports for the past five financial years.

5. The EoI shall contain sufficient supporting documentation to substantiate the experience relevant to the short-listing criteria noted above and shall not be altogether more than 80 pages, counting both sides of the page and excluding any appendices. The appendices shall be used only to list the experience certificates from the employer.
6. The attention of interested consultants is drawn to Section II, paragraph4.4, and paragraph4.9 of the AIIB's "Procurement Instructions for Recipients" June 2, 2016, setting forth the AIIB's policy on conflict of interest.
7. A Consultant will be selected in accordance with the **Particular Selection Consultant's Qualification and Based Selection (CQS)** set out in AIIB's Procurement Instructions for Recipients.
