The Chennai Kanyakumari Industrial Corridor Project, Highways and Minor Ports Department ("the Employer") for and on behalf of the Governor of State of Tamil Nadu invites bids from eligible Bidders for the construction, maintenance and completion of "Upgrading Kanchipuram Arakkonam Thiruthani Road (SH-58-II) from km 66.940 to km 86.345, km103.260 to km 108.719 and construction of Arakkonam bypass from km 86.345 to km 103.260 (16.915km) to two (2) lane with paved shoulders for a total length of 41.779 km and maintenance of entire project stretch of 41.779 km for 7 years" (in the State of Tamil Nadu on Engineering, Procurement and Construction (EPC) Mode) ("the Works").

 - Minimum average annual construction turn over of INR 320,00,00,000 calculated as total certified payments received for contracts in progress or completed within last 5 years.
 - Participation in atleast one contract with a value of at INR 274 Crore only (INR Two Hundred and Seventy Four Crore Only) or two contracts with a value of at least INR 205 Crore only (INR Two hundred and Five Crore only) in each contract within last 5 years.
