*Assignment title: Consultancy Services for Preparation of Detailed Project Report for Construction of Vehicular Underpass from km 15/500 to 16/500 of Madurai Ring Road due to expansion of Madurai Airport.*

1. The Government of Tamil Nadu has proposed to construct a vehicular underpass from km 15/500 to 16/500 of Madurai Ring Road due to the proposed Expansion of Madurai Airport and intends to prepare a Detailed Project Report for the project.
2. The selected DPR Consultant ('Consultant') shall support Tamil Nadu Road Infrastructure Development Corporation in the project approval and procurement activities.

4. The Executive Director, Tamil Nadu Road Infrastructure Development Corporation, for and on behalf of the Governor of State of Tamil Nadu, now invites eligible consulting firms to indicate their interest in providing the Services.
5. Interested consultants shall provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The responses to this Request for Expression of Interest for the Services shall comply with and will be evaluated based on the following shortlisting criteria.
  - a. The Firm should have experience of preparation of Detailed Project Report / Detailed design for at least one Bridge project of minimum 175m length and should have been designed for commercial Aircraft Runway loading.
  - b. The Consulting Firm shall have an average annual turnover more than Rs. 20 Cr exclusively from design related activities. Project Management and Construction Supervision Consultancy Services shall not be considered for this purpose.
  - c. The Firm must have an established Design office.



6. The qualification and experience of key experts will not be required, nor will be evaluated at this stage.
7. The Expression of Interest submitted must include the following:
  - An introductory letter on company letterhead with complete contact details – name of contact person and corporate role, mailing address, telephone, e-mail;
  - The organizational profile and overview of how the firm expects to deliver the Services;
  - A listing and overview of relevant projects implemented by the consultant pertaining to the Services and the shortlisting criteria outlined above and
  - Annual audited financial reports for the past five years.
8. The response to this Request for Expression of Interest shall contain sufficient supporting documentation to substantiate the experience relevant to the shortlisting criteria noted above and shall not be altogether more than 100 pages, counting both sides of the page and including any appendices.
9. Interested consultants may associate with other firms and form a team to enhance their qualification, but shall indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
10. From the shortlisted consultants, a consultant will be selected in accordance with the Quality and Cost Based Selection method.
