For and on behalf of the Governor of Tamil Nadu, The Executive Director, Tamil Nadu Road Infrastructure Development Corporation (TNRIDC), No.735, 4th floor, LLA Building Anna Salai, Chennai-600 002 herein after termed “the Client” intends to receive proposals for the services “Environmental and Social External Monitoring Consultancy for Chennai Peripheral Ring Section II and III” of Chennai Peripheral Ring Road Project – Section II & III (hereafter called the “ESEMC”). The Tamil Nadu Road Infrastructure Development Corporation (TNRIDC), the Project Implementation Unit (PIU) & Project Management Unit (PMU), under Highways and Minor Ports Department (HMPD), Tamil Nadu, receiving fund from the state government of Tamil Nadu under the contract for which this Request for Proposals is issued.

2. The Executive Director, Tamil Nadu Road Infrastructure Development Corporation, for and on behalf of the Governor of Tamil Nadu, now invites Proposals(Technical and Financial Proposals) from eligible Tenderers/Consultants for the “Environmental and Social External Monitoring Consultancy for Chennai Peripheral Ring Section II and III” fulfilling the qualification criteria as mentioned in the tender document (Request for Proposal) under single stage two envelop (Technical & Financial) system as detailed in the Table below. The duration of the contract (completion period of consulting services) is 60 months. Tenderers/Consultants are advised to note the clauses on Evaluation and Qualification Criteria to qualify for the award of the contract.

3. Procurement will be conducted through National Competitive Bidding (NCB) method and is open to all eligible Tenderers/Consultants. Tenderers/Consultants from India can participate in this tender.

4. The tender document (Request For Proposal) in English is available for free download from **30.12.2021, 11.00 Hours (IST) in the e-procurement portal www.tntenders.gov.in till 20.01.2022, 11.00 Hours (IST)**. Tenderers/Consultants will be required to register in the website e-procurement portal. No tender fee is payable. The Tenderers/Consultants would be responsible for ensuring any addenda which will be available only on the e-procurement portal is also downloaded and incorporated.

5. For submission of the tenders(Proposals), the Tenderers/Consultants is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities (CAs), authorized by Government of India for issuing DSC. Tenderers/Consultants can see the list of licensed CAs from the link www.cca.gov.in. Aspiring Tenderers/Consultants who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: www.tntenders.gov.in.

6. Tender comprise two Parts, namely the Technical Proposal and the Financial Proposal (Price Tender), and both parts must be simultaneously submitted online **in the e-procurement portal www.tntenders.gov.in on or before 20.01.2022, 11.00 Hours (IST)**. Tender validity shall be 120 days from the due date of submission of tenders(Proposals). Any tender or modifications to tender (including discount) received outside e-procurement system will not be considered. The electronic tendering system would not allow any late submission of tenders. The “TECHNICAL PROPOSAL” of the Tenders will be opened online on **20.01.2022, 12.00 Hours (IST)**, and this could be viewed by the Tenderers online. The “FINANCIAL PROPOSAL” shall remain in encrypted form in the e-procurement system until the opening. If the office happens to be closed on the date of opening of the tenders as specified, the tenders will be opened on the next working day at the same time and venue.

8. All tender (Proposal) submission must be accompanied by a Tender Fee of **Rs.10,000/-** (Indian Rupees Ten Thousand Only) and a Tender Security for an amount of **Rs. 37500 /-** (Indian Rupees Thirty Seven Thousand and Five Hundred only). Tender Fee and Tender security Payment shall be made online in the e-procurement portal www.tntenders.gov.in only as stipulated in the table below.

9. A pre-proposal conference will be conducted on **05.01.2022 at 11.30 Hours(IST)**. at the O/o The Executive Director, TNRIDC to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITC&DS Clause 13 of the tender document(Request For Proposal). Tenderers/Consultants are advised to download the tender document (Request For Proposal) prior to the pre-proposal conference in order to have a good understanding of the scope of the requirements under this contract, for discussions and clarifications at the pre-proposal conference. Last date for seeking clarifications from the Employer is **05.01.2022, 17.00 Hours (IST)** after which no queries shall be entertained.


