

BACK GROUND NOTE

Tamil Nadu Road Sector Project-II

Consultancy Services for **“Engagement of Road Safety Management Consultant to help the Government of TamilNadu in carrying out strategic and operational level initiatives to enhance Tamil Nadu’s roads safety management capacity”**

1. The Government of Tamil Nadu has conducted an executive road safety management capacity review (RSMCR) involving World Bank experts and the senior management of the responsible governmental agencies for road safety to 1) Diagnose the current road safety management capacity in the State of Tamil Nadu, 2) Develop a road safety investment strategy for GoTN in consensus with stakeholders and 3) Identify/design elements of the strategy that could be supported through TNRSP II.
2. Based on the study, the Government of Tamil Nadu has proposed for enhancing the road safety management capacity through:
 - a. Strengthening the Lead Agency
 - b. Developing Comprehensive Road Safety results frame work
 - c. Take concerted effort to address this multi-sectoral issue through proper coordination and enforcement
 - d. To review and improve the present funding and resource allocation mechanism
 - e. To develop and implement State wide Road Safety promotion plan
 - f. To focus on monitoring and evaluation including Road Accident Data Management System
 - g. To focus on Research and Development and knowledge transfer

In this context it has been proposed to engage a Road Safety Management Consultancy Service. The GoTN now invites Expression of Interest (EOI) application from eligible consultants to provide consultancy Service to carry out the Road Safety Management Consultancy Service.

Broad outline of the scope is given below:

- *Technical Assistance for the Road Safety Lead Agency (RSELG, RSMC and other implementation units) in Tamil Nadu:*
 - Support Road Safety Executive Leadership Group (RELG) and Road Safety Reference Group (RSRG) in improving road safety.
 - Establishing Road Safety Results Framework and providing advice to RSELG in implementing select tasks.
 - Prepare road safety promotion plan and coordinate in delivery of the same
 - Review and suggest improvement to Road Accident Data Management System
 - Prepare TOR for inter-agency professional development program
 - Support the preparation and implementation of Kancheepuram District Road Safety Demonstration Project and Corridor Road Safety Demonstration Project including support to the implementation units
- *Technical Assistance for Road Safety Enforcement in Tamil Nadu:*
 - Conduct training needs analysis, develop and deliver knowledge transfer program to enhance road traffic policing practices including training the trainer

- Review and develop strategies to strengthen the operational enforcement practices to enforce key safety laws
- Prepare a strategic investment plan for road traffic policing
- Prepare risk targeted patrol plan for road traffic policing at a District and sub-District level and specific plan for Kancheepuram District and associated sub-Districts including evaluation
- *Technical Assistance for Safe Motor Vehicle Regulation in Tamil Nadu:*
 - Conduct training needs analysis, develop and deliver knowledge transfer program
 - Review processes applying to regulation of motor vehicle and drivers and prepare recommendations and support Transport Department s
 - Develop operational strategies and processes to strengthen the safe regulation of motor vehicles within TamilNadu.
 - Prepare strategic investment plan for safe motor vehicle regulation
